

#### Day 1 🙈 Sunday, August 19, 2018 | Depart USA

Depart the USA on overnight international flights to Dublin. (airfare not included in package price).

# Day 2 & Monday, August 20, 2018 | Arrive Dublin | Clonmacnoise | Galway (D)

Arrive at Dublin Airport where you will be met with a "cead mile failte" (hundred thousand welcomes) by your Irish tour escort. Head west through the Midlands of Ireland, stopping at Clonmacnoise, a monastic site chosen by St. Kevin on the banks of the Shannon River. Take a guided tour and celebrate Mass at the Pope's Shelter (pending confirmation). Proceed to Galway, where you will experience its rich history and quaint narrow streets, as well as its lively pubs with traditional Irish music. Check in to your hotel. Welcome Dinner as a group and overnight in Galway.

### Day 3 🗫 Guesday, August 21, 2018 | Galway | Knock Shrine | Ballintubber Abbey (CB)

This morning, travel to Ireland's most famous pilgrimage site at Knock in County Mayo where the Blessed Mother appeared in 1879. Celebrate Mass in the Apparition Chapel (pending confirmation). From Knock, travel on to Ballintubber Abbey and visit St. Patrick's Well where the Saint baptized converts and left an imprint of his knee on a stone that remains there to this day. Return to Galway for dinner on your own. Your tour escort will advise on good pubs, live Irish music and theatre performances. Overnight in Galway.

### Day 4 🕸 Wednesday, August 22, 2018 | Cliffs of (Doher | Bunratty Castle | Killarney (CB)

Today depart for Killarney. En route, visit the majestic Cliffs of Moher, one of the most popular attractions on Ireland's Atlantic coast. Next, take a guided tour of Bunratty Castle, a beautifully restored medieval fortress. Step back in time in the Bunratty Folk Park and immerse yourself in 19th-century Irish life. On arrival, celebrate Mass in the beautiful neo-Gothic St. Mary's Cathedral (pending confirmation). Dinner on your own and overnight in Killarney.

# Day 5 & Gbursday, August 23, 2018 | Killarney | Ring of Kerry | Ouckross Mouse (CB | D)

After breakfast, depart for a tour of the famous Ring of Kerry, which includes beautiful Killarney National Park. This afternoon, enjoy a horse and buggy ride through Killarney National Park and visit the

grounds and gardens of the historic Muckross House. Celebrate Mass. Enjoy dinner and an evening of Irish culture, with world-renowned Irish storyteller, Batt Burns. Overnight in Killarney.

## Day 6 & Friday, August 24, 2018 | Blarney Castle | Dublin (CB | D)

Celebrate Mass in the beautifully restored Holy Cross Abbey, which houses a relic of the True Cross (pending confirmation). Travel to Dublin for dinner as a group and overnight.

## Day 7 & Saturday, August 25, 2018 | Dublin | World (Deeting of Families Events (CB)

After breakfast at the hotel, participate in the World Meeting of Families activities (registration fee TBA). Celebrate Mass. Dinner on your own this evening. Overnight in Dublin.

**CHILD DISCOUNT:** A cumulative child discount will be offered for families registering on this tour. The discount will be \$100 for the first child, increasing to \$200 for the second child, \$300 for the third child, etc. Children must be 16 years old or younger and a member of the registrant's immediate family in order to qualify for the discount.

**PAYMENT TERMS:** In order to meet deposit schedules with suppliers for this tour, CTS asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. Late payments may result in cancellation of your reservation. CTS also accepts Visa and MasterCard for payment. Traveler agrees not to dispute any credit card charges associated with this trip.

**CANCELLATION POLICY:** All cancellations must be received in writing. Forfeit \$350 for cancellations between time of deposit and 6/1/17. Forfeit \$850 for cancellations between 6/1/17 and 2/1/18. **TRAVEL DOCUMENTS:** Unless otherwise notified, CTS will mail you your travel information approximately 10-14 days before departure.

**ITINERARY:** The Itinerary as presented in this brochure is tentative and represents what we are planning for you, however it is subject to confirmations from many organizations. Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan. The right is reserved to alter or cancel the itinerary, at CTS's sole discretion, as it may deem necessary or advisable.

**GRATUITIES:** Gratuities for your escort, driver and guides are not included. In Europe it is customary to tip the escort four (4) Euros and the driver three (3) Euros per person per day. **ROOMS:** Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available and are discouraged because of cramped quarters and smaller beds.

LUGGAGE: Baggage is at owner's risk throughout the tour.

Carry On Luggage: You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travelers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

<u>Hazardous Materials</u>: Federal law forbids the carriage of hazardous materials aboard the aircraft, in your luggage, or on your person. A violation can result in five years imprisonment and penalties of \$250,000 USD or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives, and radioactive materials.

**HEALTH REQUIREMENTS:** Travelers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible and is not suitable for motorized scooters, walkers, and canes. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation. Should any special assistance be required, traveler agrees to bring a companion capable and willing to assist traveler.
